





Naga Pay Account Terms & Conditions

These Terms & Conditions apply to your Naga Pay account and Visa debit card. Please read them carefully. You can download a copy of these Terms & Conditions at any time from within your online account portal. Log in via our website available here.

The Naga Pay account and Visa debit card are e-money services provided by UAB "Finansinės paslaugos "Contis". Your distributor may transfer funds from a wallet and/or account you hold directly with them to cover the value of transactions you make using your Visa card.

In these Terms & Conditions:

"Distributor" means a third party who may distribute the account and card to you on our behalf. NAGA Pay GmbH is a company registered in Germany with the following registration details:

"You" means the named account holder being the authorised user of the Naga Pay account and Visa debit card.

We hold the electronic money institution license No. 53, dated 23-07-2019, issued by the Bank of Lithuania, who is our supervisory authority located at Gedimino pr. 6, LT-01103, Vilnius, Lithuania, telephone no. +370 800 50 500. The present Terms & Conditions come as an addition to our normal T&Cs. These T&Cs must be carefully read before using our Buy/Sell Crypto with FIAT feature. By using our Buy/Sell Crypto with FIAT feature, you agree to comply and be bound by these Terms and Conditions (the "Terms"). If you do not agree to the Terms, you must not use our Buy/Sell Crypto with FIAT feature.

By accepting to use our Buy/Sell Crypto with FIAT feature, you are accepting the present Terms and Conditions as well as the

Company's Terms and Conditions and all the other legal documents which are accessible anytime by everyone through the Company's website, namely https://pay.naga.com/, are binding to the user.

Buy Crypto with FIAT

The Buy Crypto with FIAT feature enables you to make purchases of available Cryptocurrencies, from your main account, using the FIAT balance you have in your account. Once the transaction is processed and finalised, the respective amount of Cryptocurrencies bought will appear in your crypto wallet located in your "crypto tab" within our application.

Sell Crypto to FIAT

The Sell Crypto for FIAT feature enables you to sell available Cryptocurrencies, from your crypto wallet and get their respective worth in FIAT, in your main account. Once the transaction is processed and finalised, the respective amount based on the worth of Cryptocurrencies sold will appear in your main account wallet within our application.

General

NAGA PAY has the right to amend the present terms and conditions without any notice unless the change is material. If a material change is affected, we will notify you immediately. Such amendment will become effective on the date specified in the notice. Unless otherwise agreed, an amendment will not affect any outstanding order or transaction or any legal rights or obligations which may already have arisen.

Cryptocurrencies are highly volatile, and trading can result in loss of your invested funds. Before investing you should be aware that cryptocurrencies may not be suitable for all investors. You should therefore carefully consider whether trading or holding digital assets is suitable for you in light of your financial condition and not invest money that you cannot afford to lose.

If the Company suspects that a NAGA PAY user has abused the rules of this Program and/or has been identified to have engaged in an abusive behaviour in any way, then the Company reserves the right at any time and at its sole discretion to immediately exclude the NAGA PAY user from this Program and take additional actions depending on the abuse. The Company will be entitled to take any action it deems necessary in order to protect the Company.

For the purpose of the above paragraph, abusive behaviour is considered (list not exhaustive):

Any actions that can be counted as fraud, manipulation or attempts to garner risk free profits;

Failure by the NAGA PAY user to meet certain requests by the Company related to this service within the specified deadline provided in the correspondence with the Company;

Please note that Naga Pay Visa card and account is an electronic money product and although we are supervised by the Bank of Lithuania, it is not covered by the Deposit Insurance System of the Republic of Lithuania. We ensure that any funds received by you are held in a segregated account so that in the unlikely event that UAB "Finansinės paslaugos "Contis" becomes insolvent your funds will be protected against claims made by creditors.
