## NAGA Feed Giveaway — Promotion Terms & Conditions

---

**Effective from:** 20 July 2026 – 17 August 2026

**Applies to:** All NAGA Group licences

### 1. Promoter

---

1. The Promotion is organised and operated by NAGA Group AG and its licensed subsidiaries (collectively, "the Promoter"), including but not limited to Naga Markets Europe Ltd, Naga Capital Ltd, Key way Markets Ltd, JME Financial Services (Pty) Ltd. Each participating entity is jointly responsible for the administration of the Promotion in respect of its own clients.
2. By participating in the Promotion, participants agree to be bound by these Terms & Conditions in their entirety and unconditionally.

### 2. Eligibility

---

3. The Promotion is open to all registered and verified clients who hold an active account with any NAGA Group entity across all NAGA Group licences. Participants must be at least eighteen (18) years of age and legally resident in an eligible jurisdiction at the time of entry.
4. Employees, contractors, and agents of NAGA Group AG and its subsidiaries, and their immediate family members, are not eligible to participate.
5. Participation is subject to the client's account being in good standing — no active restrictions, no outstanding compliance holds, no pending account closure.
6. The Promoter reserves the right to verify eligibility at any stage and to disqualify any participant found to be ineligible.
7. Participation from jurisdictions where such promotions are prohibited by applicable law is not permitted. It is the participant's sole responsibility to ensure compliance with local laws before entering.

### 3. Promotion Period

---

8. The Promotion runs for four (4) consecutive weeks, commencing on the date of the official NAGA Feed launch ("the Start Date") and ending 28 days thereafter ("the End Date"), both dates inclusive.
9. The Promotion is divided into four weekly cycles. Each cycle begins on Monday at 00:00 UTC and ends on Sunday at 23:59 UTC. The weekly leaderboard resets at the start of each new cycle.
10. The Promoter reserves the right to extend, shorten, or suspend the Promotion at any time in the event of circumstances beyond its reasonable control, subject to applicable regulatory requirements and Clause 13.



#### 4. How to Participate & Points Allocation

---

11. Eligible participants earn points by interacting with official NAGA content published on the NAGA Feed during the Promotion Period.
12. Participants earn points for interacting with official NAGA content published on the NAGA Feed during the Promotion Period as follows:
  - Posting original content on the NAGA Feed – two (2) points
  - Commenting on NAGA Feed content – one (1) point
  - Liking NAGA Feed content – one (1) point
  - Sharing NAGA Feed content – one (1) point
13. A maximum of ten (10) posts per participant per weekly cycle will count towards the points tally. Likes, comments, and shares are not subject to the same cap but are governed by the fair use and integrity provisions in Clause 9.
14. Points do not carry over between weekly cycles. At the start of each new weekly cycle (every Monday at 00:00 UTC), all participant point totals reset to zero.
15. Points are accumulated per client account. Multiple accounts held by the same individual are not permitted to participate separately; only the primary verified account will be eligible.
16. The Promoter's records of point totals shall be the definitive record for the purposes of this Promotion. In the event of a technical error or discrepancy, the Promoter's decision is final and binding.

#### 5. Weekly Prize — Apple AirPods Pro

---

17. At the end of each weekly cycle, the participant with the highest points total for that cycle will be awarded one (1) pair of Apple AirPods Pro ("Weekly Prize").
18. If two or more participants share the highest points total at the close of a weekly cycle, the winner will be determined by a random raffle conducted by the Promoter among the tied participants. The raffle outcome is final.
19. A participant may win the Weekly Prize more than once across different weekly cycles.
20. Weekly Prize winners will be notified via their registered NAGA account contact details. The Promoter will attempt to contact winners on 3 separate occasions. If a winner does not respond within 7 days of first notification, the prize may be forfeited and awarded to the next eligible participant.
21. The Weekly Prize is non-transferable and may not be exchanged for cash or any other product.

#### 6. Grand Prize — iPhone 17 Pro Max & Runner-Up Prizes

---

22. At the close of the Promotion Period, the participant with the highest cumulative points total across all four weekly cycles will be awarded one (1) Apple iPhone 17 Pro Max ("Grand Prize").
23. The five (5) participants with the next highest cumulative points totals will each receive one (1) NAGA Goodie Bag ("Runner-Up Prize"). The contents of the NAGA Goodie Bag are at the Promoter's discretion and subject to availability.
24. Weekly Prize winners are eligible to also win the Grand Prize or a Runner-Up Prize; the two prize tracks operate independently.



25. If two or more participants are tied for the Grand Prize position or for any of the five Runner-Up positions, the winner(s) will be determined by a random raffle conducted by the Promoter among the tied participants.
26. Grand Prize and Runner-Up Prize winners will be announced publicly on the NAGA Feed and notified via their registered NAGA account contact details within 3 business days of the End Date.
27. The Grand Prize and Runner-Up Prizes are non-transferable and may not be exchanged for cash or any other product.

## **7. Prize Delivery**

---

28. Prizes will be delivered to the winner's registered address on file with their respective NAGA Group entity. It is the participant's responsibility to ensure their contact and delivery address details are accurate and up to date prior to the End Date.
29. The Promoter will cover standard delivery costs. Any applicable import duties, taxes, or customs charges are the sole responsibility of the winner.
30. Prizes will be dispatched within 2 weeks of winner verification and confirmation of delivery address.
31. The Promoter accepts no liability for prizes lost, delayed, or damaged in transit once dispatched to the verified delivery address.

## **8. Tax & Regulatory Obligations**

---

32. Winners are solely responsible for any income tax, capital gains tax, or other fiscal obligations arising from the receipt of a prize, in accordance with the laws of their country of residence.
33. Where legally required, the Promoter may report prize awards to the relevant tax or regulatory authorities.
34. The Promoter makes no representation as to the tax treatment of prizes in any specific jurisdiction.

## **9. Fair Participation & Integrity**

---

35. The Promotion is intended to celebrate genuine engagement with the NAGA Feed. Any attempt to manipulate, automate, or artificially inflate point scores — including through bots, scripts, coordinated inauthentic behaviour, multiple accounts, or any other method — is strictly prohibited.
36. Posting content that is defamatory, offensive, discriminatory, misleading, in breach of any third-party intellectual property rights, or otherwise in violation of NAGA's Community Guidelines or applicable law will result in immediate disqualification and the removal of all associated points.
37. The Promoter reserves the right to audit participant activity at any point during or after the Promotion Period. Participants found to have breached these Terms & Conditions will be disqualified and will forfeit any prizes won or yet to be awarded.
38. Disqualification decisions made by the Promoter are final and binding. No correspondence will be entered into regarding disqualification.

## **10. Content Rights**

---



39. By participating in the Promotion and posting content on the NAGA Feed, participants grant NAGA a non-exclusive, royalty-free, worldwide licence to use, reproduce, and share that content for marketing and promotional purposes — including on the NAGA Feed, NAGA's website, and NAGA's social media channels — for the duration of the Promotion and for a period of twelve (12) months thereafter.
40. Participants confirm that any content they post does not infringe any third-party rights and that they have the right to grant the licence described in Clause 10.

## **11. Data Protection**

---

41. Personal data collected in connection with the Promotion will be processed in accordance with NAGA's Privacy Policy.
42. Data will be used solely for the administration of the Promotion, winner notification, prize delivery, and regulatory reporting where required.
43. Participant data will not be sold or shared with third parties other than those necessary to administer the Promotion (e.g. prize logistics partners), subject to appropriate data processing agreements.
44. Participants have the right to withdraw from the Promotion at any time. Withdrawal does not affect the validity of any points earned or actions carried out prior to withdrawal.

## **12. Limitation of Liability**

---

45. The Promoter accepts no liability for any failure of technology, system outages, or interruptions to the NAGA Feed that may affect a participant's ability to earn points during the Promotion Period.
46. The Promoter accepts no responsibility for any loss, damage, or disappointment suffered by participants as a result of accepting or using any prize.
47. Nothing in these Terms & Conditions shall limit the Promoter's liability in respect of death or personal injury caused by its negligence, fraud, or any other liability that cannot be excluded or limited by applicable law.
48. The Promoter's total aggregate liability to any participant under or in connection with the Promotion shall not exceed the retail value of the prize that participant has won (or would have won absent disqualification).

## **13. Promoter's Right to Amend or Cancel**

---

49. The Promoter reserves the right to amend, suspend, or terminate the Promotion at any time without prior notice where required by law or regulatory authority, or due to circumstances beyond the Promoter's reasonable control.
50. Any material amendment to these Terms & Conditions will be communicated to participants via the NAGA Feed and NAGA's official website.
51. In the event of cancellation prior to the End Date, the Promoter will, at its sole discretion, either distribute prizes already owing for completed weekly cycles or decline to award outstanding prizes, depending on the circumstances of cancellation.

## **14. Governing Law & Disputes**

---



- 52. Any dispute arising out of or in connection with the Promotion shall be governed by the laws of the Republic of Cyprus and shall be subject to the exclusive jurisdiction of the courts of the Republic of Cyprus.
- 53. The Promoter's decision on all matters relating to the Promotion — including but not limited to point tallies, prize allocation, eligibility, and disqualification — is final and binding. No correspondence will be entered into.

## **15. General**

---

- 54. These Terms & Conditions do not constitute a financial promotion, an offer to trade, or investment advice. Prizes are entirely separate from and do not form part of any trading activity on any NAGA Group platform.
  - 55. The Promotion is not affiliated with, endorsed by, or sponsored by Apple Inc.
  - 56. If any provision of these Terms & Conditions is found to be unlawful, void, or unenforceable, that provision shall be deemed severable and shall not affect the validity and enforceability of the remaining provisions.
  - 57. These Terms & Conditions constitute the entire agreement between the Promoter and participants in relation to the Promotion and supersede any prior representations or understandings.
