1. INTRODUCTION

3. WHAT ARE COOKIES?

Cookies are small text files which a website may put on your computer or mobile device when you first visit such website. This does not mean however, that we use them to determine the personal identity of anyone merely by visiting the NAGA website.

4. WHAT KIND OF COOKIES WE USE?

- a. **Necessary cookies:** Necessary for the basic operation of the NAGA website, enabling secure logins and consistent navigation. Without these cookies, key features may not work properly.
- b. **Preference cookies:** Allow us to remember user preferences and provide enhanced, personalized features, such as language selection or saved login details.
- c. **Statistic cookies:** Provide insights into how users interact with the NAGA website, helping us improve functionality and design. These cookies do not store personally identifiable information.
- d. **Marketing cookies:** Track user behaviour across websites to deliver personalized advertisements and measure the success of ad campaigns. These cookies are optional and can be disabled at any time.



5. HOW TO CONTROL COOKIES

You can control the cookies we store in the pop-up which appears on your first visit our website. Please note that you do not have to accept cookies, but if you turn them off or delete them, the NAGA Website may not perform as it has been designed to, possibly reducing the functionality on the Website, the options available to you, as well as the performance of the Website during your visit.
